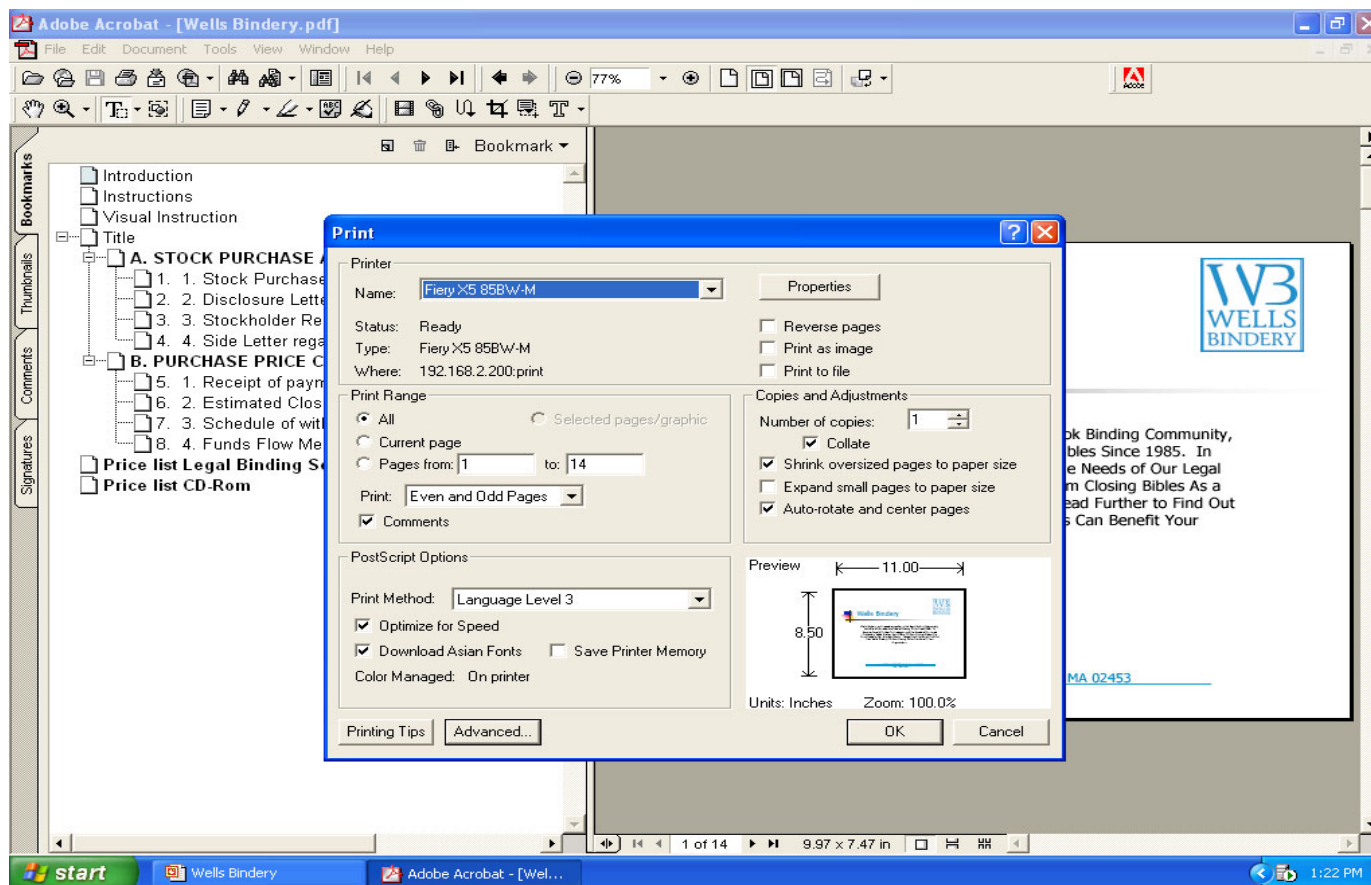
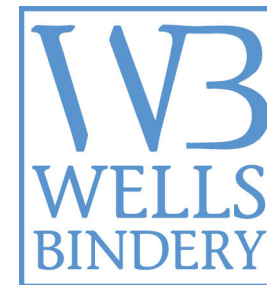
- Clicking on the bookmarks to the left will take you to specific points in the document. The arrows located at both the top and bottom of the document will allow you to go page by page through the document.
